Dear New ASEICA Family,

Congratulations and welcome to ASEICA! We are pleased that your child will be entering the international section for the school year 2021-2022. Our international section student community now consists of over 1,800 students in which over 40 nationalities are represented.

ASEICA is a non-profit association and as an accredited educational partner of the French Education Ministry, we remain committed to providing a bilingual and bicultural education to prepare our students not only for the “Option Internationale du Baccalauréat” (OIB), but for their future as global citizens. In accordance with the texts published by the French Ministry, ASEICA teachers teach literature in the language of the section. Our History-Geography teachers share the program from the French syllabus, placing an emphasis on the history and geography of the section.

About ASEICA:

ASEICA teachers are currently present in two primary schools (École Sartoux in Sophia Antipolis and École Trois Collines in Mougins), four middle schools (Collège Niki de Saint Phalle and Collège International de Valbonne in Valbonne, Collège l'Éganaude in Biot and Collège Cesar in Roquefort les Pins) and one high school (Lycée International de Valbonne).

Each parent is a member of the association, as well as all ASEICA employees. The association is directed by a board of 9 to 11 parent volunteers who meet monthly to address topics that vary from setting the association's budget and defining its policies to planning and organizing events to enrich the section experience.

Volunteers are a vital part of achieving our goals for the international section. Very little can happen without the enthusiasm and participation of parent volunteers, so we hope you will make the most of your membership and join us for:

- Volunteer meetings that are regularly held proceeding the monthly board meeting, occasional committee meetings and in primary school -IPSC (International Primary Social Committee);
- The annual General Assembly Meeting in November/December;
- Events: The International Picnic, International Day, coffee mornings, Galette/Summer camps info evening, Alumni evening, Brevet and OIB ceremonies and more...

Beyond the Classroom:

ASEICA is fortunate to have energetic and dedicated teachers who not only support the intellectual development of our students, but also take on programs and activities that enrich the overall international section experience.

- **Theater** - Primary- inclusive / Collège and Lycée – extracurricular
Weekly theater classes that culminate in a staged production each year.
- **Tech Crew** – Lycée only - extracurricular
Students learn about and engage in technical aspects of sound and lighting, as well as designing creative sets for various performances.
- **Model United Nations** - Collège and Lycée – extracurricular
Students learn to structure their opinions and develop public speaking skills as they research a country, take on roles as diplomats to debate and then develop solutions to world problems.
- **Yearbook Committee** – Lycée only - extracurricular
Students lead the yearbook project as editors, photographers, designers and copywriters.
- **Speech and Poetry Contests** – Collège and Lycée
International Speech Contest - Students from each college participate upon qualifying in an annual speech contest against representatives from other international schools across the Cote d’Azur.
- **University Guidance Counseling– Lycée**
ASEICA guidance counselors advise and assist students with the selection and application process to universities abroad.
- **Trips and Exchanges** – Collège and Lycée
Trips and Exchanges for the upcoming school year will be subject to review in accordance with national health and safety protocols

Once your child's registration has been processed, you will have access to our EcoleDirecte platform where you will be able to receive all our communications and have access to important information and documents (invoice, theatre registration file, etc.). EcoleDirecte is our main communication tool, so it is important that you make it your own. We will send you your first login details at the beginning of July. For families with a child/children already registered with ASEICA, you will be able to use your existing account.

*Keep this document for your records***ASEICA, Association pour le Soutien de l'Enseignement International sur la Côte d'Azur,**

is a non-profit association governed by the law of July 1901. Parents registering their child(ren) in the educational programs of ASEICA are all considered members of the association. Tuition fees are mostly allocated to the operating costs related to teaching. Regular payments are required in order for the Association to meet its financial obligations.

- Parents commit firmly and irrevocably to pay all tuition fees for the entire duration of enrolment in the international Anglophone section of their child(ren) and, if applicable, penalties may be charged for late or refused payment.
- Any registration for a fee-paying school trip or any other extracurricular activity organized by ASEICA is subject to full payment of tuition fees remaining due.

TUITION FEES 2021-2022**Primary: 2,930€****Collège: 1,890€****Lycée: 2,550€**

An **annual membership fee** of **20 euros** per family should be added to the registration and tuition fees.

A **registration fee of 300 euros** is payable by check at the time of registration, only for the first year. This fee of 300 euros for **each new student** is in addition to the tuition fees and is **not refundable** in case of withdrawal. Registration becomes final after payment of this fee.

Early departure:

Once the school year has started, fees must be paid in full. No refund will be made and all tuition remaining due at the time of departure must be paid in full.

In the event of early departure, **the family must inform the school and ASEICA in writing.**

DISCOUNTS**1. Discount on tuition fees:**

A **2 % discount on tuition fees applies** to registration forms received **before June 4th, 2021** opting for a one-time payment **by direct debit** of the full annual amount due. This discount will be calculated automatically at the time of the direct debit and will be indicated on your invoice.

2. Discount for multiple siblings*:

This discount applies only to families with 3 or more children enrolled in ASEICA's international section and with a sole person designated for financial responsibility. This discount will be applied to the youngest child's tuition fees:

- Three children enrolled with ASEICA: **- 15 % for the third child**
- Four children and more enrolled with ASEICA: **- 40 % for the fourth child and following children**

Tuitions fees are only payable in euros. They are invoiced annually and payable on **July 10, 2021** (unless paid by 10 monthly direct debits with an additional fee). The invoices will be available in July on your family space on our platform **EcoleDirecte** whose access codes will be addressed to you at the beginning of July.

In order to help your association control its management costs, **payment by direct debit is the general rule.**

1. Direct debit (zone SEPA: EEE countries, Switzerland and Monaco)

a) Direct debit in one payment of the total amount:

This direct debit will take place around July 10, 2021. No fee applies and you benefit from a 2% discount on the tuition fees.

b) Ten direct debits:

These direct debits take place on the 10th of the month, from July 10, 2021 to April 10, 2022.

A yearly 30 euros fee will be applied to this type of payment.

Should a direct debit be rejected by your bank:

The rejected amount should be paid by credit card on EcoleDirecte or by check. A penalty of 30 euros will be applied for any rejected direct debit. If two installments are rejected, direct debits will be suspended and the outstanding amount for the year will become due immediately.

Any change of your bank account should be notified and/or updated in EcoleDirecte before the 25th of each month, in order to be considered for the following direct debit.

2. One payment of the total amount by check in euros payable in France to ASEICA:

A check for the total amount (excluding the 300€ registration fee to be paid separately with another check) must be sent with the registration form. No discount can apply. The cheque is cashable from July 1st, 2021. A 50-euro surcharge for administration fees will be applied.

ASEICA reserves the right to refuse any other method of payment.

LATE PAYMENT AND/OR REFUSED PAYMENT

A penalty of 30 euros will apply to any payment received after the due date each month until the situation is regularized. Likewise, a penalty of 30 euros will apply in the case of a direct-debit being rejected or a check refused.

The association will take any action deemed necessary to recover unpaid amounts. All bank charges, collection and legal costs incurred are at the debtor's responsibility and will be added to the amount due.

ASEICA reserves the right to take all necessary measures in the case of non-payment of tuition fees, in particular to exclude students from extracurricular activities and/or from the possibility of benefiting from our university guidance service.
